All calculations of percentage ownership herein are based on a total of 18,625,834 shares of Common Stock issued and outstanding as of December 8th, 2023, as disclosed on the Company's Form 10-Q filed with the Securities and Exchange Commission. The MainStay High Yield Corporate Bond Fund, a registered investment Company for which Mackay Shields acts as sub-investment adviser, is no longer to be deemed as a beneficially owner. As of 12/31/23, holds 3.48%% of the outstanding common stock of the Company. New York Life Investment Management LLC, an indirect wholly owned subsidiary of New York Life and an affiliate of Mackay Shields LLC, is the manager of MainStay High Yield Corporate Bond Fund.
